The Consulta for the reform of the Basic Law (*statuto d'autonomia*) of the Autonomous Region of Trentino-South Tyrol was an expert body representing institutions and organised civil society with the mandate to a) elaborate proposals for a reform of the Basic Law and b)

to organise and supervise a participatory process of discussion of those proposals. It was the first time that such an exercise in deliberative democracy has taken place with the aim of reforming the very basis of the autonomy system. In the neighbouring Autonomous Province Bolzano/South Tyrol a similar process took place.

The tasks as Vice-President comprised coordination, supervision, chairing and legislative drafting.
