Those who are employed at the following places will not be eligible to apply: permanent staff of universities, institutions and public research and experimentation bodies, national Agency for new technologies, energy and sustainable development (ENEA) and the Italian Space Agency (ASI), as well as institutions in which the diploma of scientific perfection has been recognized as equivalent to the title of Ph.D. according to article 74, fourth paragraph of the decree of the President of the Republic 11/07/1980, n. 382.

Minimum admission requirements:

Degree (course of study lasting at least four years, provided by the teaching systems to DM 03/11/1999, n. 509), Master's degree (art. 3, paragraph 1, letter b, DM 03/11/2009, n. 509; Art. 3, paragraph 1, letter b, DM 22/10/2004, n. 270).

The Selection Committee, for the sole purpose of selection for which it was established, recognizes the equivalence of the qualification (degree and / or PhD) obtained abroad.

Those who are in possession of a degree obtained at a foreign university and who has not already been declared equivalent to an Italian degree on the basis of international agreements, in order to allow the jury to evaluate the qualification possessed, must include in the application the participation of the following documents:

- Certificate of the foreign qualification, together with a translation in Italian or English. The translation must be signed by the candidate. In the case of winning the position, candidates in possession of a degree obtained abroad must submit, within sixty (60) days from the date of signing the contract, the following documents:

- Titles translated and legalized by the competent Italian diplomatic or consular representations abroad;

- Declaration of the value of foreign qualification issued by the competent diplomatic or consular representations abroad.

In any case, in the selection of this announcement, participation cannot be allowed to those who have a degree of consanguinity or affinity up to the fourth degree with a professor in the Department of Biological and Environmental Science and Technology or with the Rector, the General Director or a member of the Board of Governors, cannot participate in the selection of this announcement.

Candidates excluded from the competition will be informed individually of the exclusion by registered letter with acknowledgment of receipt by the Director of the Department of Biological and Environmental Sciences and Technologies.

The candidates admitted to the selection means admitted conditionally. The University can, at any time, until the approval of the list, exclude a candidate from the competition for lack of requirements.

If the reasons for exclusion under this Article are determined after the completion of the competition, the Director of DiSTeBA by decree provides for the forfeiture of any right arising from the participation in the contest.

Criteria of evaluation:

1) Proven experiences in the management of distributed Data Centers;

2) Mastery in the use of automation tools and management and monitoring of Cloud and HPC systems;

3) Experience in software development for cloud applications;

4) Knowledge of Python language.

The following skills will also be evaluated:

a) knowledge / specialist skills aquired and relevant to the achievement of the objectives that the Research Infrastructure intends to achieve

b) relevance of the activity carried out in the last 2 years with the priority areas identified within the National Strategy of Intelligent Specialization (SNSI) and the ministerial planning for research in the period 2014-2020;

c) previous collaborations with public and private scientific institutions.

<u>Article 3</u> Application and submission deadline

Application to participate in each selection process should be written on plain paper following the attached format (Annex 1). It should be addressed to the Director of the Department of Di.S.Te.B.A. of the University of Salento, on exclusion penalty, by a certified e-mail message (PEC) to <u>dip.scienze.tecnologie.biologiche@cert-unile.it</u>. The documents which require signatures must also be signed by the candidate with his digital signature. Electronic documents which are not digitally signed will not be considered valid. Static formats are to be used which are not directly modifiable and should not contain macro instructions or useable codes, preferably PDF and TIFF, or non-proprietary formats like odf, txt and xml, not proprietary ones (doc, xls, etc.,).

A receipt will be sent automatically by the PEC manager or by the Administrator of the Department (in case of foreigner applicants), so it will not be necessary to call the University office to check its arrival or to send anything on paper.

<u>Article 4</u> Mode of selection

The selection is made with evaluation of degrees and publications submitted by the candidates for the programme of research and scientific area of the check followed by an interview.

The Selection Committee, made up of highly qualified experts also outside the University of Salento, without additional costs from the budget of the University, is appointed by the Director of the Department of Biological and Environmental Sciences Di.S.Te.B.A., acquired the opinion of the Department Council.

The Director of the Department, verified the existence of the requirements of the notice by the candidates who have produced application, will transmit the applications of candidates together with all annexes to the Selection Committee.

In order to formulate the order of merit of the grants, the commission has 60 (sixty) points to be allocated to the assessment of qualifications, publications and interviews. No less than 40 (forty) points should be allocated to the assessment of qualifications and publications.

The assessment of qualifications must precede the interview and results shall be made known to candidates before the oral exam by notice of the Board of the Department of Biological and Environmental Sciences Di.S.Te.B.A. .

The Commission, at its first meeting, establishes and gives note of it in the minutes: the distribution of the score among the elements evaluated, the evaluation criteria and the scoring titles and publications as well as the minimum score to be achieved for the fellowship.

At the end of its work, the Commission draws up a special report containing the evaluation criteria, the judgments, the overall score awarded to each candidate and the ratings of merit.

The ratings of merit of the candidates are formed according to the overall score, obtained by each candidate, the sum of marks obtained in the assessment of each item evaluated.

The Commission forms the merit ranking in descending order. In the case of equal merit, the candidate of younger age is preferred.

Such ranking is approved by the Director of Department of Department of Biological and Environmental Sciences Di.S.Te.B.A., which finalizing the contract.

<u>Article 5</u> Obligation of the winner

The winner of the selection establishes a relationship of self-employment under private law by signing the appropriate private contract for a fixed period of time indicated in art.1. The contract does not qualify as an employment contract.

The order established relationship does not give rise to rights for access in the roles of the University of Salento or in the personnel roles of Italian universities and university institutions.

The winner is invited to sign the contract within a period of twenty (20) days of notification of the assignment of the grant. Failure to sign the contract within that period indicates irrevocable waiver allowance and entails forfeiture of the contract.

The grant starts without fail from the first day of the month following the month in which the contract was signed.

In the case of express waiver by the assignee or of failure to sign the contract within the period indicated before, the fellowship will be offered to the candidate who is found to merit according to the ranking list.

The Director of the Department of Biological and Environmental Sciences (Di.S.Te.B.A.) in which the person concerned must conduct its business must report to the competent office of the beginning of the same activity. The Director of the Department is required to notify to the

competent office at the University of any event that could lead to termination of the contract resulting in the termination of the payment of compensation.

The winner of the selective procedure will be invited to to certify, according to the current regulations, the following conditions, facts and personal qualities:

- 1. The date and place of birth;
- 2. the political rights (foreign nationals must certify the enjoyment of civil and political rights
- in the country to citizenship or origin);
- 3. possession and number of tax code/of a valid I.D.

Moreover, the winner will have to declare that he/she has no criminal convictions; otherwise, the winners will have to certify the reported convictions, the date of judgment of the judicial authority that issued it (even if amnesty was granted, judicial pardon, amnesty, pardon, no mention etc., and even if nothing appears on the criminal record). Criminal proceedings must be indicated whatever their nature. Foreign nationals must certify, also, to have no prior criminal convictions in the State of which they are citizens and in the Italian State.

The winner must be adequate to the development of the research programme; in the case of disability, a declaration certified by a health official must be presented as proof that the disability, by nature and degree, is compatible with the activities to be carried out, with the workplace and with the equipment to be used, and that there is no harm or risk to the health and safety of themselves and others.

It shall be unaffected by Legislative Decree. 09/04/2008, n. 81 concerning health surveillance.

The conditions, facts and personal qualities self-certified by any winner of this selection procedure will be subject, by the University of Salento, to exercise appropriate checks, also random ones, about their truthfulness.

The winner, to avoid losing their right to the award, must:

- a) produce documents certifying the placement on unpaid leave for the duration of the contract if employed by public administrations;
- b) submit a declaration of option to check if exercising professional activity or has ongoing incompatible working relationships.

Before signing the contract the winner may request authorization for the continuation of activities not considered absolutely incompatible in Art. 6. In the case of unfavorable opinion, the winner will have to cease their activities to avoid losing their entitlement.

The winner who does not declare to accept the grant or does not assume service within the deadline set by the administration, will lose their right to the grant.

Only can delays due to serious health reasons or due to force majeure duly proved be justified.

Any postponement of the date of commencement and enjoyment of those documents will be allowed to be in the conditions provided for by the Decree. 26/03/2001, n. 151 concerning the protection and support of motherhood and fatherhood.

If the winner takes service, for cause, with delay on the deadline, the economic effect from the day of service socket.

<u>Article 6</u> Prevention of overlapping, incompatibility, expectations and interruptions

The grant is individual. Beneficiaries cannot combine it with income from professional activities or employment relationships. For the entire duration of the grant, the exercise of freelance activities is prohibited. The research collaborator, subject to the authorization of the scientific referent, can take on teaching positions or carry out occasional and limited self-employment contracts. The assignment of self-employment contracts, even occasional, is excluded by the University for the performance of research activities. The ownership of the research grant is incompatible with employment relationships, even part-time, with private entities.

The grant cannot be combined with scholarships for any reason whatsoever, except for those awarded by national or foreign institutions useful to supplement, with stays abroad, the research activity of the grant holders.

The grant cannot be compatible with participation in courses of bachelor or master, PhD with scholarship or medical specialization, in Italy or abroad, with the participation of master's degrees and involves the placement on leave without checks for the employee in service by public administrations although with rapport or working part-time.

Prior authorization of the Director of Department, after hearing the Scientific Coordinator, the grant holder may carry out an occupational activity involving services rendered free of charge at voluntary associations or cooperatives of a non-profit social welfare nature, to the full performance of their research tasks.

Consistent with the research activities assigned to them and approved by the scientific and Referent Council authorization Department, grant holders may participate in the execution of research and consultancy on behalf of third parties commissioned to the University pursuant to art. 66 of Presidential Decree 382/80 and the distribution of the proceeds in the manner established by the current regulations.

Article 7 Rights and duties of the grant holder

The holder is to take part exclusively in research activities under the contract, previously evaluated by the Department as being compatible with the research programmes of the Department. The holder can disseminate the results of research only with the consent of the scientist or the Department.

The research activities of the holder of the research is carried out within the Department and / or in other scientific facilities of the University according to the research programme. Any research outside the University must be given by the Scientific Coordinator of reference and approved by the Department Council.

In any case, the grant holder must not participate in activities of mere technical support within specific research programmes.

The Department provides the grant holder the necessary support to the implementation of its programme of research by giving access to equipment, resources and use of the technical-administrative services.

The holder is required to adopt, at all times, safe working procedures that comply with legislation and, in particular, to take the necessary precautions in terms of health and safety.

The grant holder within the first 10 days of the last month of each year and / or within 10 days following the end of the contract, is required to submit to the Department Council a detailed report on the research activities, endorsed by the Contact Scientific.

In the event of serious shortcomings (unjustified suspension for more than ten consecutive days; breach of the rules regarding incompatibility) reported by the Scientific Coordinator or Director to the Board of the Department, the contract may be terminated by resolution of the Board hearing the official concerned.

Against the decision to terminate the contract subject may make use of the Academic Senate, which decides definitively.

Notwithstanding the provisions of art. 10 of this notice, the 'research and the check may be suspended, in the cases provided by law, for pregnancy and serious illness. The 'duration of the grant cannot be reduced because of the above suspension.

Not a suspension and, consequently, should not be recovered a total period of leave of absence of no more than thirty days in any year.

Article 8 Monitoring and evaluation of Research undertaken

The Board of the Department, within 10 days of receiving the report prepared by the contract holder under the prior art. 7 on the reasoned opinion of the Scientific Coordinator, expresses an opinion on the work performed by the grant holder.

In the event of a negative opinion, the contract shall be automatically terminated.

Article 9 Health and safety Monitoring

The Director of the Department, where the research grant is carried out, is responsible, in accordance with the University Regulations for the implementation of standards for the safety and health of workers (DR n. 1029 09/05/2007) fulfilling their obligations under Legislative Decree. n. 81/2008 and, in particular, the activation of health surveillance of the researcher in the manner and with the requirements of the law.

Article 10 Taxation, social security and insurance

The grants referred to in this announcement shall follow, in tax matters, the provisions of art. 4 of Law 08.13.1984, n. 476 and subsequent modifications and additions, as well as in social security, those in art. 2, paragraphs 26 and following, of the law 08/08/1995, n. 335, and subsequent amendments.
