UNISALENTO FOR UKRAINE

OPEN CALL FOR N. 10 INTERNATIONAL STUDENTS COMING FROM UKRAINE

(ACADEMIC YEAR 2021-2022)

ART. 1 – OBJECTIVES

UNISALENTOFORUKRAINE – OPEN CALL FOR INTERNATIONAL STUDENTS – is an initiative adopted within the framework of the University's internationalisation policies and aimed at promoting concrete actions to welcome and host students coming from Ukraine and seeking international protection.

UniSalento launches the present open call for hosting n. 10 students of any nationality, affected by the war in Ukraine, coming from Ukrainian universities, who intend to carry out a period of study at UniSalento in the academic year 2021/2022, by attending one or more single courses.

The period of study may not be longer than six months. The students may enrol at single courses in one of the Degree programmes offered by UniSalento (<https://international.unisalento.it/>).

ART. 2 – BENEFITS

Selected students will be entitled to the following benefits:

- ✓ Exemption from fees
- ✓ Free board and lodging for up to 6 months
- ✓ A total flat-rate contribution of € 600,00
- ✓ Free Italian language course at the University Language Centre
- ✓ Assistance from the staff of the UniSalento Welcome Office in dealing with administrative procedures and with the integration of the student into university life

ART. 3 – ADMISSION REQUIREMENTS

The call for applications is only open to applicants who meet the following requirements:

- They must be students of any nationality, currently living in Ukraine, affected by the war in Ukraine
- They must be enrolled in an Ukrainian university
- They must not be enrolled in another Italian university for the academic year 2021/2022

ART. 4 – DOCUMENTS REQUIRED FOR THE APPLICATION

Applications must be submitted using the attached form (annex 1-Application Form) and sent exclusively by e-mail to the following address: carmen.taurino@unisalento.it. Applications will be evaluated in the order in which they are received by a committee appointed by the Rector. The call will be closed once the ten available positions are filled.

The application must include the following documents:

1. Applicant's CV
2. A scanned copy of the Applicant's passport (or any other identity document) in course of validity
3. Enrolment certificate
4. Motivational letter

The International Relations Office may request, at any time, additional documentation if needed by the selection committee.

ART. 5 – NOTIFICATION AND ACCEPTANCE OF THE BENEFITS

Upon receiving the formal notification that their application has been accepted, the selected candidates will be asked to fill in a form, in which they must declare to accept or decline the benefits.

ART. 6 – MEDICAL INSURANCE

UniSalento will provide insurance coverage against accidents and civil liability. Beneficiaries must take out a health insurance policy to cover any expenses that may be incurred by illness or accident.

ART. 7 – PERSON IN CHARGE OF APPLICATION PROCEDURE
